You have paid for full registration/breeding rights. Your puppy has been Micro-chipped already; you must register this chip in your name within 30 days of getting your puppy. Failure to do so will VOID this contract COMPLETELY. Your puppy will come with his/her registration papers listed above & pedigree. The puppy is of purebred quality and to the best of our knowledge we find its pedigree to be true and accurate. The purchaser understands that the registration company owns the registration paperwork and not the breeder, so if for any reason papers get pulled, the buyer cannot hold the breeder responsible either. Furthermore, the buyer cannot hold the breeder responsible for any contradictive genetic breed testing.

due when your puppy is picked-up or 2 weeks before expected flight. There will be charges for me holding a puppy if I hold your puppy past 9 weeks old, fee of \$25.00 a week (if the puppy must wait for one of my flight dates there will not be a charge).

Should you choose to pass on an available puppy, this price will be honored for **1 year** from the date this contract is signed. The price may then be subject to change.

To the best of my knowledge I am selling a healthy puppy. It will be deemed healthy by a Licensed Vet before it leaves me via flight/pick-up. Southern Grace Schnauzers will not be liable for any expenses, including but not limited to veterinary bills or shipping. You (the purchaser) must take your puppy to a Licensed Vet within 3 working days of receiving the puppy with the exception of any vet affiliated with Banfield or Pet Smart. Use of this

clinic is completely prohibited by Southern Grace Schnauzers doing so will completely void this contract. You must then send me a copy of the vet's examination within 1 day of the said appointment. **Failing to do so will void this entire health guarantee.** If the puppy is not seen fit by a Licensed Vet you must return the puppy immediately at your expense (within 72 hours), with a Licensed Vet's explanation to prove defect. At that time, I will give you a full refund for the price of the puppy alone or replace the puppy with another puppy of equal value. No replacement or refund will be given on a deceased puppy without a full Necropsy performed to determine cause of death. In the unlikely event that your puppy has an unforeseen hereditary defect within two years of age I will replace your puppy with a puppy of the same quality for the price of the puppy alone and you return the ill puppy to me at your expense, with a Licensed Vet's explanation to prove the defect. If you put the puppy down without my approval this contract is VOID. Once again, no replacement or refund will be given on a deceased puppy without a full Necropsy performed to determine cause of death. I will not make any guarantees for any kind or worm, coccidiosis, parvo, kennel cough, hypoglycemia or Guardia. These parasites and viruses are all too common in puppies and can be contracted from soil, pet stores and many other places. I also cannot guarantee disposition, life span, size or color of any puppy.

I do guarantee fertility on your puppy for at least one litter. If you find your puppy/dog to be sterile contact me right away. If for any reason you decide to re-sell, trade, lease or in any other manner, transfer ownership and/or possession of this puppy, you agree that the puppy/dog will only go to a **pet** home and that you will agree to have this puppy/dog spayed/neutered prior to leaving your home. **This puppy/dog may never go to another breeder of any kind.** If Southern Grace Schnauzers finds out the said puppy/dog goes to anyone not neutered/spayed the Buyer agrees to pay \$5,000.00 as a fine to Southern Grace Schnauzers. Both parties agree that any legal disputes of this contract must be held in Montgomery County, Clarksville, Tn.

You agree to not "knowingly" sell or transfer puppies whelped to any person or firm connected with the business of resale or wholesale of dogs.

I, the buyer or representative of the puppy have read, understand and agree to the terms above. Acceptance of the said puppy is acceptance of this agreement in full.
